FISH BUYERS PERMIT – BLACKFELLOWS CAVES

Pursuant to Sections 200 and 222 of the Local Government Act 1999, and Council By-laws

of		
below	by granted permission to carry on the business of buying fish on that part of Council land described (the "trading stand") subject to the following conditions and other conditions which may be imposed Council.	
1.	This permit is not valid unless the permit fee of \$ has been paid.	
2.	This permit is issued in respect of the year.	
3.	This permit expires on the 30 th day of September at the end of the year for which it was issued.	
4.	The permit holder shall at all times comply with the Local Government Act 1999 and Regulation and Council by laws.	
5.	The permit holder agrees to indemnify and to keep indemnified and to hold harmless the Councilits servants and agents against all actions, costs, claims, damages, charges and expense whatsoever which may be brought or made or claimed against them in relation to the issuing of this permit.	
6.	The permit holder shall take out and keep current a public risk insurance policy, insuring the perm holder for the minimum sum of ten million dollars (\$10,000,000) against all actions, costs, claims damages, charges and expenses which may be brought or made or claimed against the perm holder in relation to the activity.	
7.	The permit holder shall ensure that no bait is placed on any concrete or asphalted area on or neather trading stand.	
8.	The permit holder shall ensure that any concreted or asphalted area on or near the trading stan is kept clean and sanitary, and hosed down and disinfected at the end of each day the tradin stand is used by the permit holder.	
9.	The permit holder shall ensure that all vehicles and equipment are removed at the close of business each day the trading stand is used.	
10.	The permit holder shall ensure that <u>all rubbish</u> generated from carrying on his or her business at the trading stand is <u>carted away at the end of each day</u> that the trading stand is used by the perm holder. The rubbish is not to be disposed of in any public litter bin within the Council area.	
11.	No transactions are to be made at the scales used by fishermen to weigh their catch. Sales must only be made in the area allocated, please refer attached map.
